# Thanks for getting involved! Make sure you read this before submitting your entry.

- 1** Your design(s) should be inspired by the film(s) of your choosing (one film per design), but **MUST NOT** feature the title of the movie, nor any original artwork from the official movie posters.
- 2** Designs must be A2 in size (420 x 594mm) with 3mm bleed all round (which will be trimmed once printed), and will be displayed in portrait format.
- 3** Your artwork must be set up as CMYK for print, and preferably supplied as a print-ready PDF. TIFF or JPEG format at 300dpi is also acceptable.
- 4** Winning posters will be printed by Now Showing.
- 5** Alternatively, winners can print their own posters should they require specific special finishes, inks etc. (Please state this when entering.)
- 6** The deadline for submissions is Monday 15 August 2016.  
Any submissions made later will not be accepted.
- 7** You can submit as many entries as you wish.
- 8** Each submission must not exceed 30MB in file size.

## **Additional terms & prizes**

- 9** All submissions will be reviewed by our panel of judges, and six winners selected. Winning entrants will be notified on Friday 19 August 2016.
- 10** The winning posters will be displayed as part of the Nicholas Winding Refn Presents season, at a screening of *Suspiria* at The Cameo cinema in Edinburgh on Monday 22 August, and for a time afterwards.
- 11** The following prizes will be distributed among the winners: a year's [Picturehouse Membership](#); two pairs of tickets to see [Suspiria](#) on 22 August; a [quad poster for The Neon Demon](#); tshirts for *The Neon Demon*; [The Act of Seeing](#) by Nicholas Winding Refn; a Poster Project [Beyond Words screen print](#).

You have designed and created an A2 (420mm wide x 594mm high) poster ('Poster') for one of the above motion pictures ('Movies').

1. By agreement hereof, and your submission of the Poster, you hereby agree, represent, warrant and undertake that: (i) the artwork embodied on the Poster is your sole creation and does not infringe the rights of any third party and (ii) you have legal capacity, right, power and authority to enter into this Agreement.
2. You hereby grant to us the right to: (i) exhibit the Poster at the Now Showing event on 22 August 2016 ('the Event') if selected as a winning entry; (ii) include an image of the Poster within a book about the Event ('Book') and to manufacture, distribute, and promote the same; (iii) display and distribute an image of the Poster on the Now Showing website and through social channels; (iv) use the image for PR purposes in connection with the Event; (v) reproduce your professional name in relation to paragraph (i) (ii) (iii) and (iv) above. Use of your name shall not misrepresent the extent of your involvement with the Event.
